- European Research Council
 - Frontier research by the best individual teams
- Future and Emerging Technologies
 - Collaborative research to open new fields of innovation

Types of Actions

RIA – Research & Innovation Action

Funding for research projects tackling clearly defined challenges, which can lead to the development of new knowledge or a new technology.

Funding rate: 100% of eligible costs

IA – Innovation Action

Funding is more focused on closer-to-the-market activities. For example, prototyping, testing, demonstrating, piloting, scaling-up etc. if they aim at producing new or improved products or services.

- ✓ Prototyping, Testing, Demonstrating, Piloting ...
- ✓ May include limited R&D Activities

Funding rate: 70% of eligible costs (except for non-profit legal entities, where a rate of 100% applies)

CSA – Coordination Support Action (no R&D)

Funding covers the coordination and networking of research and innovation projects, programmes and policies. Funding for research and innovation per se is covered elsewhere.

Funding rate: 100% of eligible costs

- SC1-BHC-11-2020: Advancing the safety assessment of chemicals without the use of animal testing. Deadline date: 07 April 2020 (RIA)
- SC1-BHC-17-2020: Global Alliance for Chronic Diseases (GACD) Prevention and/or early diagnosis of cancer. Deadline date: 07 April 2020 (RIA)
- SC1-BHC-34-2020: New approaches for clinical management and prevention of resistant bacterial infections in high prevalence settings. Deadline date: 07 April 2020 (RIA)
- SC1-DTH-04-2020: International cooperation in smart living environments for ageing people. Deadline date: 22 April 2020 (RIA)

- FNR-11-2020: Prospecting aquatic and terrestrial natural biological resources for biologically active compounds. Deadline date: 22 January 2020 (RIA)
- FNR-18-2020: Sustainability of bio-based products international governance aspects and market update. Deadline date: 22 January 2020 (CSA)
- SFS-05-2018-2019-2020: New and emerging risks to plant health. Deadline date: 22 January 2020 (RIA)

Climate Change

- LC-CLA-17-2020: Polar climate: understanding the polar processes in a global context in the Arctic and Antarctic Regions. Deadline date: 13 February 2020 (RIA)
- SC5-10-2019-2020: Raw materials innovation actions: exploration and Earth observation in support of sustainable mining. Deadline date: 13 February 2020 (IA)
- SC5-27-2020: Strengthening international collaboration: enhanced natural treatment solutions for water security and ecological quality in cities.

 Deadline date: 13 February 2020 1 (RIA)

 Deadline date: 29 January 2020 (IA)
- LC-SC3-RES-1-2019-2020: Developing the next generation of renewable energy technologies. Deadline date: 1 April 2020 (RIA)
- LC-SC3-RES-37-2020. Combined clean biofuel production and phytoremediation solutions from contaminated lands worldwide Deadline date: 21 April 2020 (RIA)
- LC-SC3-CC-1-2018-2019-2020. Social Sciences and Humanities (SSH) aspects of the Clean-Energy Transition. Deadline date: 01 September 2020 (RIA)
